OUTCOME-BASED PERFORMANCE CONTRACTS TO DEVELOP AND DELIVER LARGE SCALE MARSH CREATION AND/OR RIDGE RESTORATION PROJECTS



1.0 INTRODUCTION

The Coastal Protection and Restoration Authority (CPRA) is seeking qualified Proposers to provide full delivery of marsh creation and/or ridge restoration projects within southeast Louisiana. This Request for Statements of Interest and Qualifications (RSIQ) is solicited pursuant to La. R.S. 49:214.6.2 and 49:214.7, (http://legis.la.gov/legis/Law.aspx?d=672078) and (http://legis.la.gov/legis/Law.aspx?d=285577), which created an alternative project delivery method, known as outcome-based performance contracting, for use by the CPRA to award a contract to finance, design, construct, and monitor integrated coastal protection projects (**Figure 1**). This RSIQ shall allow CPRA to evaluate and select qualified Proposers who shall be invited to submit proposals to a subsequent Request for Proposal (RFP) for full delivery of marsh creation and/or ridge restoration projects. The RFP shall describe in detail the types and amounts of large-scale marsh creation and/or ridge restoration projects sought by CPRA, and shall define the minimum project outcomes, goals or outputs associated with each habitat type.

The term "Outcome-based performance contractor" is defined in La. R.S. 49:214.7. For purposes of this solicitation the terms "outcome-based performance contractor", "Proposer", "entity" and "contractor" may be used interchangeably and shall be understood as to be synonymous with the term "outcome-based performance contractor" as defined in the La. R.S. 49:214.7. The term "Owner" is defined in La. R.S. 49:214.7 as the Coastal Protection and Restoration Authority.

This RSIQ is for the evaluation and selection of qualified Proposers to provide full delivery of completed projects involving a comprehensive suite of services that may include, but is not limited to, the following: project finance, project site identification, property rights acquisition, scientific and engineering analyses of project sites, access routes and borrow areas; topographic, bathymetric, magnetometric and hydrographic surveys; geotechnical investigations and analyses; hydrologic and hydraulic analyses and simulations; water quality analyses; environmental, biological and natural resource investigations; regulatory permitting and compliance; construction; and, post-construction monitoring, maintenance and adaptive management.



It is the intent of CPRA to select multiple Proposers from this solicitation. CPRA shall establish a Qualification Review Committee for evaluation of the responses to this RSIQ. The Qualification Review Committee shall evaluate the responses in accordance with the scoring methodology and criteria as identified and set forth in the Evaluation Criteria (**Enclosure A**). CPRA shall select the Proposers who's Statement of Interest and Qualifications best conforms to this solicitation and is most advantageous to the State of Louisiana and CPRA. CPRA reserves the right to cancel this solicitation at its discretion.

The highest qualified Proposer(s) determined through this RSIQ shall be invited to propose specific projects through a separate RFP process. Contracts for projects selected via the RFP are presently anticipated to range up to \$65 million in value.

Proposers electing to submit a Statement of Interest and Qualifications (SIQ) as the prime contractor, partner, member, joint venture, or coventurer cannot be listed as a subcontractor on another Proposer's SIQ. Proposers not submitting as the prime contractor, partner, member, or coventurer are allowed to be listed as a subcontractor or consultant on as many SIQ's as they deem appropriate. Proposers who are prime contractors on existing contracts with the CPRA are allowed to submit on this RSIQ.

In accordance with Executive Order Number JBE 2018-15, by submitting a response to this solicitation, the Proposer certifies and agrees that the following information is correct: In preparing its response, the Proposer has considered all proposals submitted from qualified, potential subcontractors and suppliers, and has not, in the solicitation, selection, or commercial treatment of any subcontractor or supplier, refused to transact or terminated business activities, or taken other actions intended to limit commercial relations, with a person or entity that is engaging in commercial transactions in Israel or Israelic controlled territories, with the specific intent to accomplish a boycott or divestment of Israel. The Proposer has also not retaliated against any person or other entity for reporting such refusal, termination, or commercially limiting actions. The state reserves the right to reject the response of the Proposer if this certification is subsequently determined to be false, and to terminate any contract awarded based on such a false response.

2.0 OUTCOME-BASED PERFORMANCE CONTRACTING

"Outcome-based performance contract (OBPC)" means a delivery method by which the CPRA shall contract with a Proposer for results-based, specific agreed-upon outcomes, goals, or outputs, with payment provided by an owner upon successful completion of the pre-agreed result, outcome, goal, output, or result. Outcome-based performance contracts shall include the following:

- a. A requirement that a substantial portion of the payment be conditioned on the achievement of specific outcomes based on defined performance targets. For purposes of this subparagraph, "substantial portion" shall mean no less than seventy-five percent of the total project cost.
- b. A process through which performance indicators can be assessed by the owner to determine whether performance targets have been met.
- c. A schedule and calculation of consequences for contractors based on performance, to include payments that would be earned if performance targets are met or the imposition of penalties or other payment adjustments if performance targets are not met.

An outcome-based performance contractor shall employ, or have as a partner, member, coventurer, or subcontractor, persons or a firm with persons who are duly licensed and registered to provide the services required to complete the project and to do business in the State of Louisiana The standard professional engineer and land surveyor requirements provided for in La. R.S. 37:681 et seq., and the rules and regulations of the Louisiana Professional Engineering and Land Surveying Board, shall apply to the team members providing design services. All applicable professional registrations and licenses shall be obtained and valid prior to the submittal date for this RSIQ.

The standard contractor qualifications as provided for in La. R.S. 37:2150 et seq., and the current rules and regulations of the State Licensing Board for Contractors shall apply to the OBPC component providing construction services utilized by the outcome-based performance contractor, based upon the applicable categories for the specific project types to be delivered, currently anticipated to be Heavy Construction or Dredging. All registrations and licenses for each team member shall be obtained and valid prior to the submittal date for this RSIQ.

3.0 PROJECT BACKGROUND, LOCATION AND DESCRIPTION

Project details and requirements will be included in a subsequent RFP; however, projects must be located within the Barataria Basin of Louisiana (**Enclosure B**) and consistent with the identified marsh creation and/or ridge restoration project areas in the 2017 Coastal Master Plan and the Louisiana Trustee Implementation Group Strategic Restoration Plan and Environmental Assessment #3: Restoration of Wetlands, Coastal, and Nearshore Habitats in the Barataria Basin, Louisiana (<u>https://la-dwh.com/wp-content/uploads/2018/03/Final_SRP.EA_508-Compliant.pdf</u>). Master Plan Project Fact Sheets can be found in Attachment A8 of the 2017 Coastal Master Plan (<u>http://coastal.la.gov/wp-content/uploads/2017/04/Attachment-A8_FINAL_10.02.2017.pdf</u>).

Projects may be implemented through the Natural Resource Damage Assessment (NRDA) restoration planning effort to restore for damages caused by the Deepwater Horizon oil spill as well as other coastal planning and restoration funding sources. These areas are suffering from land loss and habitat shift due to oiling from the Deepwater Horizon oil spill, hydrologic alteration, sediment deprivation, subsidence, and saltwater intrusion. The objectives of these projects are to re-establish and nourish inland marsh and ridge habitat by hydraulically and mechanically dredging material from riverine, inshore and offshore borrow sources. Marsh creation and/or ridge restoration shall increase habitat

areas and help improve storm buffering ability as a part of the multiple lines of defense protecting geographically and socially vulnerable communities.

Discrete projects shall be solicited through a subsequent RFP, and shall consist of inland marsh creation and/or ridge restoration via dredged sediment that may come from multiple potential borrow sources to be identified and secured by the Proposer upon approval by CPRA. Potential sediment sources may be inshore, riverine, and offshore. Projects may also entail mechanical excavation and grading for ridge restoration and shoreline protection.

4.0 OBPC STAFFING REQUIREMENTS

Successful full delivery of marsh creation and/or ridge restoration projects through CPRA's outcomebased performance contracting requires a broad range of business, technical, and construction expertise. Due to statutory mandates and the complexities in delivering completed projects, it is typical for Proposers to employ specialized personnel on the project delivery team, which may include employees of the outcome-based performance contractor, partners, members, coventurers, subcontractors, or consultants.

Following is a list of the desired key positions for the team. Additional expertise may be needed based on site-specific conditions of projects. Proposers should consider the general requirements of project types listed in this RSIQ and utilize their professional judgment and experience on additional staff requirements. Note that individuals may serve in multiple roles.

- The financing members of the team;
- Project Manager with relevant and demonstrated experience successfully delivering ecosystem restoration projects. The Project Manager shall serve as the point of contact with CPRA.
- Property acquisition members of the team;
- Professional Land Surveyor and members of the team with experience executing topographic, bathymetric, hydrographic, magnetometer, and boundary surveys before, during and after construction in coastal environments;
- Design component members for the areas of expertise specific to marsh creation and/or ridge restoration, including civil engineer(s), coastal engineer(s), geotechnical engineer(s) and restoration scientists;
- Construction Manager and team members experienced in coastal habitat restoration, including dredging, transportation, and placement of sediment and associated logistics;
- Project Scientists and other experts on the team experienced with coastal ecosystem restoration and permitting experience through the Louisiana Department of Natural Resources Coastal Use Permitting Program, U.S. Army Corps of Engineers, New Orleans District, Section 10/404 program and experience with U.S. Fish and Wildlife Service, NOAA-National Marine Fisheries, and Louisiana Department of Wildlife and Fisheries. The Project Scientists shall be responsible for regulatory permitting and compliance, monitoring plan development, postconstruction monitoring, and adaptive management.

CPRA requires that key personnel listed in the Proposer's SIQ be assigned to any project(s) contracted through subsequent RFP(s) and remain assigned for the duration of such contract(s). Should substitutions become necessary, Proposers may propose substitutions of equal or better-qualified replacement personnel to CPRA for approval. Requests for changes in any of the key personnel, Principal Participants, the Designer, or Specialty Subcontractors shall be particularly scrutinized.

Proposers are advised that contractors of the State of Louisiana may, in certain circumstances, be deemed public employees as defined by the Ethics Commission. **Full disclosure to CPRA is required of any potential conflicts of interest.** Any potential conflicts shall be resolved with the Ethics Commission prior to submitting proposals in response to an RFP.

5.0 ANTICIPATED PROPOSER RESPONSIBILITIES

The anticipated proposer responsibilities may include, but not limited to, the items below for the delivery of a successful marsh creation and/or ridge restoration project through CPRA's OBPC. Detailed work plans specific to awarded projects shall be the responsibility of the Proposer but may be required for submittal in a subsequent RFP.

- <u>Project Management</u> Proposer shall be responsible for providing overall management of the project. Major emphasis shall be placed on the timely delivery of functioning ecosystem services associated with the relevant habitat types, locations, and amounts.
- <u>Project Finance</u> Proposer shall provide all capital to finance the delivery of marsh creation and/or ridge restoration projects. Capital must be secured through private sources.
- Property Proposer, at his sole cost and expense, shall acquire and secure all property rights necessary to construct and deliver marsh creation/or and ridge restoration projects. This may include, but is not limited to, property rights to the project site(s), access route(s), borrow area(s), and any buffers needed to protect adjacent sensitive habitats. Proposer is responsible for all reasonable due diligence as may be necessary to develop marsh creation and/or ridge restoration projects, including but not limited to: environmental screening to identify/survey potential protected species, archaeological sites, historical architecture structures, contamination, etc. of the site. Proposer shall encumber project site(s) with servitudes to protect ecosystem services delivered by the project(s). The duration of servitudes shall be no less than twenty-five (25) years. Each servitude must have good, marketable title free of liens and incompatible encumbrances. At its sole discretion, as may be described in a subsequent RFP, CPRA may require property rights to be transferred to the state. Proposer shall provide CPRA with rights of access for the durations of all servitudes to allow CPRA to monitor project performance and durability. However, in accordance with La. R.S.49:214.7(H), CPRA, if necessary and upon request from Proposer, may exercise any statutorily created power for the purpose of acquiring lands or estates or interests in lands, including but not limited to easements, servitudes, access agreements, and oyster lease acquisitions, to the extent that the CPRA finds that such actions serves integrated coastal protection purposes.
- <u>Surveying</u> Proposer shall perform all topographic, bathymetric, geophysical, magnetometer, and boundary surveys necessary to execute the project. This work shall include, but not be limited to, recordation of servitudes and monumentation of servitude boundaries. An as-built survey shall also be required after construction.
- <u>Borrow Areas</u> Proposer shall be solely responsible for obtaining rights to borrow material and associated construction easements. Proposer shall perform all reasonable due diligence as may be necessary to harvest and transport material for the project, including but not limited to: environmental screening to identify/survey potential protected species, archaeological sites, historical architecture structures, contamination, etc. of the site. CPRA reserves the right to review and approve borrow sources during the RFP process.

- <u>Site Analysis and Engineering Design</u> Proposer shall complete all necessary scientific and engineering analyses of the project site and borrow area as may be needed to deliver the marsh creation and/or ridge restoration project. A thorough understanding of the physical, chemical and biological factors of the site are required for successful designs with minimal adverse environmental effects.
- <u>Regulatory Permitting and Compliance</u> Proposer shall be solely responsible for 1) securing all regulatory permits, and 2) for full and complete compliance with all Federal, state and local regulations for the duration of the contract. CPRA shall not be party to such permits. Additional regulatory review and oversight by NRDA trustee representatives or other agencies may be described in the RFP.
- <u>Construction</u> Proposer shall construct the project according to the permitted engineering design, including all earthwork, structures, vegetative plantings, and seeding and all other activities pertinent to the installation of marsh creation and/or ridge restoration.
- Post-Construction Monitoring, Maintenance, and Adaptive Management Project monitoring approaches have been established by CPRA through decades of project assessment experience. In general, it is anticipated that project Design Documents shall include a monitoring plan that outlines measurable project goals and a plan for assessing those goals including the timing, means, and methods to be employed for assessment. More details on the performance criteria shall be made available in a subsequent RFP. An adaptive management plan will be requested in the RFP submittal to provide criteria and triggers for managing the project site(s) for optimal provision of ecosystem services for the duration of the servitude. References for the Proposer should include, but not be limited to, the Deepwater Horizon (DWH) Natural Resource Damage Assessment Trustees Monitoring and Adaptive Management Procedures and Guidelines Manual (http://www.gulfspillrestoration.noaa.gov/sites/default/files/2018 01 TC MAM Procedures Guidelines Manual 12-2017 508 c.pdf), Appendix F from the 2017 Coastal Master Plan (http://coastal.la.gov/wp-content/uploads/2017/04/Appendix-F_FINAL_04.04.2017.pdf), the Coastwide Reference Monitoring System program (CRMS; https://lacoast.gov/crms2/), and future Adaptive Management documentation from Deepwater Horizon (DWH) Natural Resource Damage Assessment. More details on the requirements of monitoring shall be made available in a subsequent RFP, but the Proposer should be aware that projects are part of a larger ecosystem restoration effort and therefore evaluations and performance measures shall need to be comparable to other projects.

6.0 VOLUME I – GENERAL SUBMITTAL REQUIREMENTS

Proposers should submit an SIQ that highlights the experience of successful implementation of marsh creation and/or ridge restoration projects. The Qualification Review Committee shall review the SIQs to select Proposers that display successful histories delivering full delivery marsh creation and/or ridge restoration projects and a record of accomplishment with full delivery and/or similar project implementation processes of coastal projects. The submittal shall provide the sections outlined below. Note that several elements listed below are to be provided on the Experience and Qualifications Form (EQF-1) (**Enclosure C**) or as appendices to the SIQ.

6.1 Cover Letter

The Proposer shall submit a cover letter introducing the Proposer's team and its commitment to successful completion of coastal projects through CPRA's Outcome-Based Performance Contracting program. The letter should summarize the Proposer's particular expertise, resources, and advantages that their team shall bring to CPRA. The letter shall clearly state the name, title, firm affiliation, telephone number, email address, and mailing address for the Proposer's primary point of contact for this RSIQ. The primary point of contact must be an officer of the Proposer firm and must represent that they are authorized to legally execute contracts on behalf of the firm.

6.2 Executive Summary

The SIQ shall include a summary that more thoroughly describes the Proposer's project team and its overall experience that applies to the successful execution of OBPC to provide marsh creation and/or ridge restoration. This summary should provide an overview of the contractor's resources and advantages that their team shall bring to CPRA. The Proposer shall present the name, telephone number, email address, and mailing address of the Proposer's Project Manager.

6.3 Business Organization and History

The SIQ shall describe the OBPC Proposer team's organization and history, including years in business and scale of operations for ecosystem restoration. This information should include the Proposer's legal entity and structure, size of company including number of employees (total and in Louisiana), and all office locations. If the Proposer is a corporation, include date of incorporation, place of incorporation, officers and directors, and affiliates, partner corporations, and subsidiaries. If the Proposer is a Limited Liability Company (LLC), include date of organization, place of organization, members, managing member, and identification of the majority member and its percentage interest. If the Proposer is a joint venture (JV), include date of JV formation, name / address of each JV partner, principals of each JV partner, and identification of the majority JV partner and its percentage interest.

The Proposer shall describe that they employ, or have as a partner, member, coventurer, or subcontractor, persons, or a firm with persons who are duly licensed and registered to provide the services required to complete the project and to do business in the State of Louisiana. All applicable professional registrations and licenses shall be obtained and valid prior to submittal of the SIQ.

6.3.1 CPRA fully participates in and encourages participation in the Hudson Initiative Program. The State of Louisiana Veteran and Hudson Initiatives are designed to provide additional opportunities for Louisiana-based small entrepreneurships (sometimes referred to as "LaVets" and "SEs" respectively) to participate in contracting and procurement with the state. Proposers who themselves are a Hudson Initiative small entrepreneurship certified through the Louisiana Economic Development for small entrepreneurship under the Hudson Initiative Program (HIP) should identify themselves as such and provide appropriate documentation in an appendix to the SIQ. Proposers who engage one or more subcontractors certified through the Louisiana Economic Development for small entrepreneurship under the HIP should identify those subcontractors and provide appropriate documentation in an appendix to the SIQ. Certifications must be valid at the date of the SIQ submittal (https://www.opportunitylouisiana.com/small-business/special-programs-for-small-business/hudson-initiative). Documentation provided by the Proposer for this section will not be considered in the SIQ page limit.

6.3.2 Submittals shall also include a statement of the Proposer's ability and intention to provide equal opportunities in recruitment, selection, appointment, promotion, training, and related employment areas in connection with the OBPC. The SIQ may also describe the extent to which the Proposer intends to self-perform any work and how Louisiana businesses may be utilized. Documentation provided by the Proposer for this section will not be considered in the SIQ page limit.

6.4 Project Management and Staffing

Submittals must include concise statements of qualifications and experience for key proposed management and staffing. This section should demonstrate the depth and breadth of resources needed for efficient delivery of durable projects. Proposals should describe an organizational structure that portrays the roles and responsibilities of project team members. The qualifications of individuals for the key staff positions listed below are to be summarized in the SIQ and presented in resume format prescribed on the EQF-1 (**Enclosure C**). Key staff resumes in the EQF-1 shall clearly state the location (city and state) of the office in which the staff member resides. Individuals may serve in multiple roles, but each individual's resume shall be limited to two (2) pages or less. Subcontractors and consultants holding key roles in the team organization should be included and clearly identified as such. Each individual's firm affiliation should be indicated on the organization chart. The organization chart should be accompanied by a narrative summary indicating the functional responsibilities and designated authorities of personnel and entities identified.

6.5 Financing Team Experience

Submittals must include concise statements of qualifications and experience for proposed financing members of the team. This section should describe the financial capacity and the capability to sustain and execute projects of a maximum of ten years duration. Proposals should demonstrate the Proposer's experience in financing complex projects through post-construction performance monitoring. The qualifications of proposed financing members of the team are to be summarized in the SIQ and presented in resume format prescribed on the EQF-1 (**Enclosure C**). Resumes in the EQF-1 shall clearly state the location (city and state) of the office in which the member resides. Each financing team member's resume shall be limited to two (2) pages or less.

6.6 Project Experience

Project experience should emphasize ecosystem restoration projects delivering coastal habitat type(s). Emphasis on project selection should include projects in the United States which provided similar coastal site characteristics, riverine construction, marine construction, geotechnical conditions, and interaction with riverine and marsh systems. Projects submitted should demonstrate significant experience with hydraulic and/or mechanical dredging, transport, and placement.

For each project, Proposer must provide at least one (1) name and contact number for the Owner and/or primary regulatory authority for reference. The Qualification Review Committee may select a minimum of two or up to the total number of projects and contacts listed for reference checks. Proposers shall be responsible for verifying the contact numbers submitted in the SIQ. The information obtained from the reference checks shall be incorporated into the scoring of this section. If additional information is needed on the relevant projects listed by the

Proposer, CPRA reserves the right to pursue additional references and shall incorporate the performance information obtained into the scoring of this section.

6.7 Technical Approach

Submittals should provide a general description of the Proposer's site analyses, engineering and design methodologies to marsh creation and/or ridge restoration projects. Proposers should present any special skills and proficiencies the technical team might apply in the engineering process. This section may also describe tools and techniques the Proposer applies to reduce project risk and ensure successful restoration metrics are achieved.

Proposers should also demonstrate general familiarity with relevant Natural Resource Damage Assessment and Restoration planning process and documents associated with the *Deep Water Horizon* case, Louisiana's Comprehensive Master Plan for a Sustainable Coast (June 2, 2017), and CPRA protocols and engineering expectations for marsh creation and/or ridge restoration projects. A general approach to monitoring and adaptive management should be included in this section.

Submittals must include concise statements of qualifications and experience for key design component members for the areas of expertise specific to the project. The qualifications of proposed design component members of the team are to be summarized in the SIQ and presented in resume format prescribed on the EQF-1 (**Enclosure C**). Resumes in the EQF-1 shall clearly state the location (city and state) of the office in which the member resides. Each design component member's resume shall be limited to two (2) pages or less.

6.8 Construction Capabilities and Approach

The SIQ should provide information on construction methodologies previously used by the Proposer on other projects of similar size, type, and complexity as detailed in Sections 3.0 through 5.0. Proposers should present detailed information regarding specialized experience, equipment, monitoring, and field practices that apply to the installation of created marshes and restored ridge habitat. Protocols that reduce the possibility of adverse environmental impacts and increase the likelihood of successful ecological outcomes (e.g. durable marsh elevations, rapid establishment of vegetation) should be emphasized.

Submittals must include concise statements of qualifications, experience, and resources for the construction team component. The qualifications of the proposed construction team component are to be summarized in the SIQ and presented in resume format prescribed on the EQF-1 (**Enclosure C**). Resumes in the EQF-1 shall clearly state the location (city and state) of the office in which the member resides. The construction team component's resume(s) shall be limited to two (2) pages or less.

6.9 Appendices: Standard Forms and Supporting Documents

Documentation provided by the Proposer for this section will not be considered in the SIQ page limit. Standard forms, professional licenses and certificates, company licenses to work in Louisiana, Hudson Initiative Certificate, and other required documents are to be appended to the SIQ as described below.

6.9.1 Appendix I: Experience and Qualifications Form (EQF-1) (Enclosure C)

The Experience and Qualifications Form (Enclosure C) shall be used to support CPRA's understanding of the project team and their previous interaction on projects described in the SIQ. Additionally, the form shall provide details for the relevant projects described in Block 13, which shall be used for reference checks. A maximum of ten (10) project references should be noted in the form's project description (Block 13). CPRA reserves the right to call any of those listed project owners or contacts as listed on this form, or individuals other than those listed, to verify the Proposer's quality of work and owner satisfaction. Names listed on this form must precisely match the names filed with the Louisiana Secretary of State, Corporation Division, and the Louisiana State Licensing Board for Contractors. Block 14 is intended to show a concise matrix of the key team members and a history of the projects that those individuals have worked on together. A more detailed showcasing of projects should be in the SIQ as described in Section 6.6 above. This form shall be used to support in CPRA's understanding of the project team and their previous interaction on projects described in the SIQ. All resumes should be submitted as part of this form, but again each individual's resume shall be limited to two (2) pages or less.

6.9.2 Appendix II: Licensure and Certifications

All professional licenses and certificates, company licenses to work in Louisiana, Hudson Initiative Certificate(s) and other required documents referenced in the RSIQ, should be referenced in the appropriate section of the SIQ and supporting documentation included in Appendix II.

The OBPC construction team member(s) shall be licensed in accordance with the rules of the Louisiana State Licensing Board for Contractors at the time of SIQ submittal, and maintain licensure for the duration of any subsequent contract(s). Engineering and surveying shall be performed in compliance with the registration law for Professional Engineers and Land Surveyors (L.R.S. 37:681 through 37:703) and the rules of the Board of Registration for Professional Engineers and Land Surveyors.

6.9.3 Appendix III: Equal Opportunity Statement

6.9.4 Appendix IV: Qualification Review Committee Conflicts of Interest Acknowledgement

A Qualification Review Committee shall be comprised of CPRA staff and/or representatives from the Governor's Office of Coastal Activities. The Proposer must avoid any situation where personal and business relationships could have, or give the appearance of having, influence on any potential member of the Qualification Review Committee. The Proposer must avoid actions, discussions, and communications (oral or written) with any member of the Qualification Review Committee that might be perceived as exerting influence over a Qualification Review Committee member. The Proposer shall submit with its SIQ a completed Qualification Review Committee Conflicts of Interest Acknowledgement (Enclosure E).


