 - Task Force was briefed on OMAR-Technical Assessment; ORLSS Technical Assessment;
 Atchafalaya Basin (Coon Trap and Sustainable River Program).
 - Also discussed the Atchafalaya Basin Modeling Outlets & Lower Mississippi Comprehensive Study.

 - The Task Force was briefed on:
 - A number of authorizations that the Federal government has related to the Atchafalaya basin.
 - There is a need to express a sense of urgency regarding the Atchafalaya Basin to Congress.

- There's a possible opportunity to add language to WRDA that will be passed (hopefully) next year to add the Atchafalaya Basin to that study along with the Lower MS River.
- Also discussed possibility to revisit the Atchafalaya Floodway Plan.

 - Enhance outreach that highlights the importance of the Atchafalaya Basin locally and nationally.
 - Urge and request Congress fully fund construction of finalized USACE studies relevant to the management of the Atchafalaya Basin as well as funding authorized studies.
 - Urge the USACE to include holistic management of the Atchafalaya Basin, with ecological restoration, as a core component in the authorized Lower MS river comprehensive management study.
 - o USACE to complete the Atchafalaya Floodway system
 - Finalize and incorporate current studies within a larger examination of the current hydrology of the Basin including inputs for sediment and water at the ORCC and their eventual fate.
 - o Examine ways to better contain and mobilize sediment within the main channel.
 - Examine current management of the ORCC and the impacts altered flows between the MS and Atchafalaya Rivers.
 - Update the State's Atchafalaya Basin Mater Plan to include current conditions and challenges and as informed by ARBRE Task Force.
 - CPRA Board and CPRA to better engage the public concerning the management of the Atchafalaya Basin.
 - Recommend the ARBRE Task Force be used to discuss and inform potential management actions within the Atchafalaya Basin.
